2021 Survey of Publicly Funded Problem Gambling Services

The 2021 Survey of Publicly Funded Problem Gambling Services in the United States was released in conjunction with the National Conference on Gambling Addiction and Responsible Gambling 2022 in Boston. Throughout FY2022, The State Survey Workgroup met many times, for planning, questionnaire review, timeline development, release of questionnaires to the states and then follow-up and fact checking with states. The Workgroup supported the researchers, Problem Gambling Solutions, to troubleshoot and make decisions regarding both questions and processes throughout the survey. The data collection was much more difficult this past cycle than in the previous five surveys because of complications due to the COVID pandemic. State personnel were working from home. Phone numbers and contact information had changed, and there was not a way to connect through an administrative assistant or operator. State administrators were juggling more responsibilities than ever with staff shortages and with less support, all the while managing personal lives amidst COVID and accomplishing their professional roles. There were states that were not interested in participating in the survey, so other means of finding out the data were explored by the researchers, but this data was not as complete and took additional time. It was necessary to have data from all states in order to present an accurate composite picture through the survey report. The data collection portion of the survey took four months longer than scheduled in the timeline, pushing the release back into FY2023.

The release included an announcement to NCPG national conference attendees through a new podcast sponsored by NAADGS and led by Brianne Doura-Schawohl and through press releases. The <u>2021 Survey of Publicly Funded Problem Gambling Services in the United States</u> can be found in its entirety at <u>https://naadgs.org/</u>. In that report, summaries of the most current state data and contact information can be found in the appendices.

The survey revealed that \$94 million was directed toward problem gambling services in the United States during fiscal 2021. Of each dollar received from legalized gambling activities across the nation, only \$.0029 (a little more than one-quarter of a cent) went toward services for gambling disorders. There are 42 states that invest any funding in services for problem gambling. These facts and a plethora of others can be found in the survey at https://naadgs.org. The appendices to the survey have a list of states' contributions to problem gambling services, as well as each state having a separate page for information particular to that state. State contacts are kept up to date on the individual state pages. This survey contains extensive detailed information about gambling disorder services in the United States.

Though the survey findings and publication have been released, the work continues as the contractors update the budget data for each state in both fiscal year 2023 and 2024 under their current project contract. NAADGS is grateful to have received sufficient funding support to continue with annual updates for two years following the initial release so that data can remain current without gaps. Because this survey is the only one of its kind in the United States, it is important to have current data for use throughout the country by researchers, legislators and policy makers, state administrators and the public.

Thanks to Entain Foundation as the primary source of funding for this project, with secondary funding received from EPIC Risk Management and KindBridge Institute. NAADGS is grateful to work with entities that appreciate the need for such work and have generously funded this project.





Website

Salzmedia, NAADGS' contractor for website services, has done extensive work on the website in the past year. As a consequence of the *2021 Survey of Publicly Funded Problem Gambling Services in the United States* being published, each of the 51 individual state pages of the website has been updated with new graphs and charts to inform the reader of the state's gambling revenues per capita, investment in problem gambling services per capita, state rankings (of 51 jurisdictions) for investment in disordered gambling services, and in states' total gambling losses, i.e. money spent on legal gambling. The pages are descriptive and concise with at-a-glance information. Contacts for each state have been updated.

In FY2022, the Resource Library section of the website was re-organized to allow a more intuitive directory for articles in the library. New section topics were established or re-organized to include:

NAADGS News

National Resources

Disordered Gambling Services (includes prevention, treatment and recovery tabs with articles by topic)

Research

State Resources

Legislation

Each section has current articles dated within the past three years. An archive was developed with the same headings so that a reader can find older articles by topic area.

Preparation for a 3-year strategic plan

Since 2019, NAADGS has been working on the basic business building blocks of a nonprofit corporation by refreshing its mission, vision, and values statements, establishing a new name and logo, and updating by-laws, all of these items completed by July 2021. This past year has been focused on strategic planning. We have worked with the NAADGS' workgroups to establish goal(s) and objectives designed to accomplish each goal. Once the objectives were defined, we worked to write them as SMART objectives, making each one simple, measurable,

achievable, relevant, and time bound. NAADGS has included as many members as possible in the workgroups to gather from broad-based wisdom and experience. Members have a voice in the work and direction of the association and should feel a part of the work objectives that are set forth.

While these workgroups were focused on their goals and SMART objectives, the Board of Directors completed a SWOT analysis, which described the internal strengths and weaknesses, as well as the external opportunities and threats.

All of these components will be organized into the NAADGS 3-year strategic plan in the first half of FY2023.

Podcast



NAADGS has contracted with Brianne Doura-Schawohl, of Doura-Schawohl Consulting, to produce a podcast ten times a year that focuses on what is happening in the United States regarding gambling activities, legislation and regulations, with guests and interviews that will be of interest to the public as well as NAADGS members. The inaugural podcast aired July 22, 2022, in Boston.

For the release of the 2021 Survey of Publicly Funded Problem Gambling Services in the United States. Ms. Doura-Schawohl interviewed Principal

Investigator Jeffrey Marotta, PhD, regarding the findings of the survey. That podcast can be heard through a link on <u>www.naadgs.org</u> main page. All subsequent podcasts will be linked on the website as they occur.

Meetings

NAADGS has Members' Meetings once every three months, with the first meeting of each fiscal new year being the Annual Members' Meeting. In July 2021, the National Conference on Problem Gambling was held remotely, so the NAADGS Annual meeting did not occur in conjunction with the NCPG conference but occurred in August 2021 via Zoom meeting. Because it was virtual, the meeting was two hours in duration instead of a half day or full day.

The Board of Directors generally meets in person for the February meeting. In FY2022 an inperson meeting was planned, but due to an upsurge in the Omicron COVID virus the in-person meeting was cancelled and held via Zoom instead. The next in-person Board of Directors meeting is scheduled for February 2023 in Phoenix, Arizona.

NAADGS meeting minutes are posted to the NAADGS website when the minutes are approved following the next regularly scheduled meeting.

Learning Communities

Under the leadership of the Learning Communities Workgroup, NAADGS has offered outstanding opportunities for learning and growth to both its members and their guests throughout the past year. This fiscal year, Victor Ortiz, MA, Department of Public Health, did an engaging and challenging presentation regarding *Diversity, Equity, and Inclusion*. Jeffrey Marotta, PhD, presented *The Effects of COVID-19 on Problem Gambling Services* and Dr. Michelle Malkin presented on *Gambling and Crime*. These presentations are 1 hour each and are presented through Zoom. The link can be shared with interested parties that are not part of NAADGS, so participation often includes 35-50 participants.


The Learning Community Workgroup has conducted a poll of the membership to prioritize learning interests for its offerings in the coming fiscal year.

Marketing and Communications

NAADGS sends out a monthly newsletter to its member list to keep members informed about events,

trainings, work processes, and





other news of interest. In FY 2022, ten issues of the NAADGS News were distributed to a mailing list of 63 recipients.

In FY2022, a new NAADGS brochure was designed to use at exhibits and conferences to describe NAADGS, its mission, vision and values. It also outlines opportunities for donating, sponsoring, and partnering with the association. It has a QR code included that links to the *2021 Survey of Publicly Funded Problem Gambling Services in the United States.*

Newspaper interviews were conducted with two news agencies during FY2022, including Jacob Meyer and Shin Wu Tan of the *Washington Post* in an article entitled "With sports betting boom comes increase in problem gamblers, experts say." Marsha Mercer of the Pew Institute wrote an article entitled "As Sports Betting Grows, States Tackle Teenage Problem Gambling," published July 12, 2022.

NAADGS hosted an informational exhibit at the NCPG conference in Boston in July 2022. The exhibit gave NAADGS members the opportunity to meet many of the 600-plus conference attendees from throughout the country and to share the Executive Summary for the newly released *2021 Survey of Publicly Funded Problem Gambling Services in the United States.*

Budget

NAADGS' primary source of revenue is the dues that are paid by its member states. In FY2022, NAADGS realized 96 percent of budgeted income from dues, or \$64,250. NAADGS depends on the dues to operate and provide services to its members. NAADGS continues to invite state participation, grow its membership, and provide invaluable resources to members to encourage participation.

In addition to the funds from state dues, NAADGS received an additional \$35,000 from donors who sponsored the *2021 Survey of Publicly Funded Problem Gambling Services in the United States.* As previously mentioned, NAADGS is grateful to Entain Foundation, primary sponsor of the survey, for its continued support of \$25,000 to continue the collection of state budget data during 2022. Also assisting with survey funding support was Kindbridge and EPIC Risk Management. This foundational funding allows for state budget data to be collected for two years following completion of the initial survey.

By fiscal policy, NAADGS must keep at least two months' operating revenue in an interestbearing account. NAADGS also sets aside funding for the next survey to be conducted, although those funds can be used for other purposes should sponsors be found to fund the survey efforts.

Staffing

NAADGS continues to be staffed by one half-time position, an executive director. Accounting needs are contracted to KMK Bookkeeping proprietor Kate Scalley. Web design and maintenance is contracted through Salzmedia, owned by Cynthia Salzman. Administrative services continue to be contracted with Admin Solutions Group. All contractors are paid on an hourly basis.

The future

NAADGS is optimistic for the future. We have done much of the work toward developing a strategic plan with Greta Coe from Oregon at the helm. We have developed the necessary parts of a comprehensive strategic plan. In the coming year all those parts will be organized and consolidated to have a comprehensive three-year strategic plan in place. Workgroups are already finalizing their content areas' SMART objectives as the timeline indicates, to reach their defined goals.

NAADGS expects to see continued growth in its membership and participation, with additional states becoming paying members of the association. Over and above adding states as members, NAADGS looks forward to additional participation by encouraging multiple NAADGS participants in each state. With active workgroups focusing on prevention and standards of care, marketing and communication, fundraising, data and emerging trends, the use of data collected through the survey and through other sources, advocacy, and other areas of emphases, NAADGS encourages state personnel that have expertise to participate collaboratively in workgroups as the association focuses on objectives developed through the strategic planning process.

NAADGS continues to strive to offer the best resources and tools to its members. NAADGS will continue to focus on collecting a resource library of materials so that reference materials and research is readily available to members as they seek to grow their state programs. Learning communities will continue to offer scholarly training to the members to provide guidance and examples for successful gambling disorder services.

Fundraising is an on-going activity at NAADGS. In the coming fiscal year, that will continue as the organization establishes updated direction and sets future priorities. Grant funding will be sought to support NAADGS' goals. The organization currently has grant funding from three companies for the current survey. The State Survey Workgroup will soon start planning its efforts in securing funding for the next complete survey in 2024. NAADGS will continue its efforts to seek funding to support additional programmatic staffing. We will seek funds to establish a peer recovery support for problem gambling program and other initiatives as identified by the Board of Directors.

NAADGS continues to expand our network to meet new people who are working toward the same goals. We look forward to meeting new colleagues in the world of problem gambling and social responsibility – friends who are innovators and who have social responsibility at the forefront of their work, friends who are planners and implementors, philanthropists and expansive thinkers, looking for ways to prevent harm from gambling. We look forward to partnering with amazing people and companies as we work toward our mission, vision, and values. We are excited to see what 2023 holds for us!
